

Home Buyer Assistance Program



DEFERRED PAYMENT, NO INTEREST, 2ND MORTGAGE LOANS UP TO \$90,000

Human Resource Council (HRC) operates a loan fund that <u>assists qualified households</u> purchase a home within Mineral, Missoula and Ravalli Counties.

BOTTOM LINE

- Household annual gross income <u>CANNOT EXCEED</u> 80% of median (See table below) up to the day of closing.
- ^o Household <u>MUST CONTRIBUTE</u> minimum down-payment of 3% of home's purchase price.
- Applicants <u>MUST QUALIFY</u> for 30-year, fixed rate of interest (not subprime) 1ST mortgage with lender of choice.
- ^o Mortgage payment (PITI) must be <u>AT LEAST 28%</u> & <u>NO MORE THAN 32%</u> of monthly gross income.
- Total debt ratio SHOULD NOT EXCEED 42% of monthly gross income.
- ^o Applicants <u>MUST ATTEND & COMPLETE</u> an HRC approved homeownership course <u>PRIOR TO CLOSING.</u>
- House/Property <u>MUST MEET</u> Housing Quality Standards, Lead Based Paint standards and standards required by the lender.
- Home chosen <u>MUST BE</u> owner-occupied or vacant Not a rental unless you're the renter.
- Purchase Price of home <u>MAY NOT EXCEED</u> HUD-HOME 2024 Maximum Purchase Price Limits: Missoula County \$ 461,000.00 Ravalli County \$474,000.00 Mineral County \$356,000.00 Human Resource Council

HRC is able to assist qualifying households purchase a home in Mineral, Missoula and Ravalli Counties with a deferred payment, no interest second mortgage. The loan fills the gap between the purchase price and the greatest amount the lender will lend the household. The maximum level of assistance is \$90,000. *However, only the minimum amount of assistance needed to enable the participant to purchase a modest home will be provided.* There are no payments on the financial assistance while the household is paying on the superior mortgage. Repayment would be required once the superior mortgage is satisfied. If the household elects to refinance or sell the home, HRC's mortgage needs to be included in the loan payoff.
